All rentals require a **security deposit**. The standard security deposit rate is **US\$10** and is to be charged with the rental fee prior to the collection date. It should be submitted via email transfer (bank details to be provided) or in cash when the rental form has been completed .

Dress Condition

The Lessee acknowledges that the dress is in a good condition at the time of rental.

Any **damages or stains** incurred **during the rental period** will result in a **deduction** from the **deposit**.

Care and Use

The Lessee agrees to handle the dress with care and only use it for its intended purpose. The dress shall **not** be altered, modified, or tempered with in any way.

Return of Dress

The Lessee shall return the dress to the Lessor by _____ in the same condition as received. Late returns may result in additional charges, consisting of 15 % of the total rental fee, for each additional day. If additional rescheduling of a rental period is required, please contact us again as soon as possible. Rescheduling must be approved for late return fees not to exceed.

Cleaning

The Lessor provides the dress in a clean and well-maintained condition. The Lessee shall return the dress in the same condition. If cleaning is required, the Lessor may deduct cleaning fees from the deposit.

Liability

The Lessee assumes all liability for the dress during the rental period. The Lessor is not responsible for any injuries, accidents, or damages arising from the dress' use.

Cancelation & Refunds

If the Lessee cancels the rental, the **deposit** is **non-refundable**. Refunds are only provided if the Lessor is unable to fulfil the rental due to unforeseen circumstances.

Indemnification

The Lessee agrees to indemnify and hold harmless the Lessor from any claims or damages arising from the dress' use./

Governing Law

This Agreement shall be governed by the laws of Zimbabwe/ United Kingdom.

RENTAL CONTRACT

By signing this contract, I _____ agree to the following terms:

1. I agree to reserve and rent the garment is hereby described as follows:

- Description of the Rented item: _____
- Full Rental Price: US\$ _____
- The rental period is for three (3) days only, including the day when the it was taken. I understand that I am responsible for the return of the rented garment within this period. I must notify Herah Rhema's Gown Renting if I am going to extend the rental time period before the rental time is up.
- Date to be Taken: _____
- Date to be Returned: _____

2. If I fail to return the rented garment within the allotted time period, I understand that I will be charged a penalty equivalent to 15% of the total rental fee, and this fee will be charged on a daily basis. The charge will continue until the gown is returned.

3. Upon choosing my rented garment, I will pay a non-refundable reservation fee equivalent to 25% of the rental fee in order to reserve the garment. The said non-refundable reservation fee does not form part of the rental fee. If after the reservation made and prior to the taking of the garment as agreed upon by **me** and Herah Rhema Emporium. If I am no longer interested in renting the garment, the said non-refundable fee will be forfeited in favour of Herah Rhema Emporium.

4. Upon taking the garment I will pay in full the rental fee as determined by Herah Rhema Emporium. Further, I will make a deposit of US\$100, / US\$200- (depending with the gown). The said deposit is refundable to me after my return of the rented garment less of any penalties for late return or damages that may be assessed by Herah Rhema Emporium upon my return of the said rented garment.

5. Rented garments will be returned in the same condition that it was given to me. Any rips, tears or damages to the rented garment will result in a hold of the deposit until the rented garment is repaired at my expense. The **expenses** of the **repair** shall be **deducted** from the **refundable deposit** posted by me. In case my refundable deposit is **insufficient** to cover the said expenses, I will pay Herah Rhema Emporium of the **excess**. Should the damage be so severe that the rented garment cannot be cleaned or repaired to its original state, **I bind myself to pay the full retail price of the rented garment.**

6. I will also deposit a valid Identification Card to Herah Rhema Emporium upon taking the rented garment and filling in of this form and the same shall be returned only upon the return of the rented garment at the condition when the same was taken by me.

7. I bind myself to take good care of the rented garment. I will not spray perfume on it, spill wine or put any food stuff on the gown, nor have any makeup stains on the dress, nor cause any damage to it.

8. I understand that this contract is legal and binding and I accept all conditions and terms of this agreement.
